The International Association of Marine Aids to Navigation and Lighthouse Authorities (IALA), within the framework of its IALA World-Wide Academy, will host an

IALA training seminar on the IALA Risk Management Tool – PAWSA & IWRAP Mk2

from 15 to 19 November 2010, at IALA HQ,

20ter, rue Schnapper, St Germain en Laye, 78100, France.

The seminar will show how PAWSA and IWRAP Mk2 complement each other, review the utility of PAWSA to national administrations and the need for trained facilitators and introduce the revised and recently updated IWRAP Mk2. The seminar will also provide training on the use of IWRAP Mk2, using practical examples.

Participants will benefit from the presence of expert trainers and by means of practical examples.

Background

This seminar continues the series of seminars for training in the use of the IALA Risk Management Tool. It follows the IWRAP Mk2 introductory seminar held in Malaysia in 2009 and the first training seminar in February 2010. It is set in the context of IALA Recommendation 0-134 on Risk Management Tools for Ports and Restricted Waterways.

Objective

The seminar aims to provide an opportunity for delegates to experience the capability of the IALA Risk Management Tool box, including the qualitative PAWSA tool and the quantitative IWRAP Mk2 together with simulation techniques.

Specifically, the seminar will:

- Present the IALA Risk Management Tool Box and introduce the different tools;
- Review the utility of PAWSA, including experience from previous assessments;
- Present the way to prepare, organise and conclude a PAWSA workshop;
- Present IWRAP Mk2 and the associated methodology;
- Introduce the difference between the free and commercial versions of IWRAP Mk2;
- Allow participants to conduct a number of practical exercises with their own laptop;
- Illustrate the complementarity of PAWSA and IWRAP Mk2 and the use of simulation.

Attendance

The seminar is directed towards those involved in the design, marking and management of waterways (as laid down in SOLAS Chapter V, Regulations 12 & 13). There is a limit of 40 delegates, each of which is requested to bring his / her own laptop.
